ITEM #1

The ARC recommends that the Board fo Trustees approve the attached changes to the Design Standards. These changes involve changes to the way the MSSA and its committees would review window replacement and new window installation and fall under the category of "windows - General" on page 7 of the Design Standards and "Windows - Replacement Windows" on page 7 and page 8.

Changes since the initial presentation are the removal of the word "must" and replacing it with the word "should". Removal of the portion of the sentence beginning with "therefore, direct replacement of......by Board of Trustees."

ITEM #2

The ARC recommends that the board of Trustees approve the attached changes to the Design Standards. These changes involve changes to the was the MSSA and its committees would review decking for the exterior decks or covered porches. The change is shown on page 6 under "Porches."

ITEM #3

The ARC recommends that the Board of Trustees approve the attached changes to the Design Standards. These changes involve changes to the way the MSSA and its committees would review changes to chimneys and fireplaces. The changes are shown on page 4 under the second paragraph and on page 4 under "Distinguishing Characteristics of Historic Buildings – Chimneys" and on page 5 under "General Considerations."

Changes since the initial presentation of this motion include a sentence that allows for consideration of the condition, safety and location of the fireplace and chimney. The sentence was added to allow for variables to be considered rather than utterly deny the removal of the fireplace/chimney unit as was implied in the original motion.
