Since there were no further nominations, these officers were elected by acclamation. E. Billington took her place as Secretary.

Presidents Comments

Kent Ballow opened the meeting by commending those board members who have served and have completed their term(s). Kent welcomed the new board members, including those who are beginning their second term: Anne Williams (Presbyterian caucus), Lane Price (Episcopal caucus), Anne Worthen (Baptist caucus), Britton Watson (Consolidated caucus), Frannie Smith (Methodist caucus), and the at large members, Morgan Merrill, Bill Cox, and Bob Monfore.

MOTION by President, Kent Ballow: Kent stated that the MAEFC Board nominee is Evan Price and the MAEFC Board President nominee is Keith Barton. The Board of Trustees unanimously accepted these two nominations for the MAEFC Board.

Corporate Resolutions

Motion by Finance Chair, Bob Monfore: All checks in an amount greater than \$5,500 require two signatures and that the following signatories be designated for the Monteagle Sunday School Assembly bank accounts: Kent E. The motion passed unanimously.

Scott Parrish passed out Conflict of Interest papers requiring all trustee signatures.

Unfinished Business:

Ellie Billington read the minutes of the July 25, 2014, meeting which was adjourned to July 26, 2014 at 8:30 A.M. Two corrections were offered:

1. Lisa Hammett moved and Barry Moody second a motion to issue a 99 year lease to Melville M. Barnes, Jr. (100% undivided interest) effective August 4, 2014. The motion carried with opposition or abstention. (This should read "with no opposition or abstention.") 2. Treasurer Monfore moved for the committee and the Board unanimously approved the 2014/2015 Unrestricted Budget as modified with two votes in opposition and no one abstaining. (This should read "and the board approved, but not unanimously") **Motion:** David Pilcher moved to pass the minutes as corrected. The minutes were approved with the two corrections.

New Business:

Andy Spickard suggested we "process" the Annual Meeting earlier that day. A healthy discussion ensued concerning ways to improve membership communication and greater understanding of the different funds: unrestricted and restricted.

Motion: Frannie Smith asked for approval of July 17, 2015, as the Woman's Association's date for the cottage tour and bazaar. The motion was seconded. The motion passed unanimously.
