Code of Regulation (COR) Spotlight

As you may or may not know, the Assembly is regulated by two very portant documents. One is the bylaws, and the other is the rules and regulations.

The bylaws are the specific rules that outline precisely how the Assembly is governed. The rules and regulations focus on our day-to-day life, including behavior and expectations. Both are included in the membership directory which is mailed each uary. Every member should

read them every year.

That said, this is the beginning of a series of articles that will spotlight a different subject from the Code of Regulation. This month: G-7, fire safety.

Trash fires of any kind on Assembly grounds both within and without the fenced

area is prohibited. Metal grills/barbecue broiling stands may be used outdoors on leaseholds but not on park land unless supervised by Assembly summer or permanent personnel. Open fires are prohibited on leaseholds and Assembly property.

> Campfires are permitted within stone firings on the cleared areas at Warren Point and campground. Use of the Assembly trailertype barbecue grill is permitted on the cleared area at Warren Point.



Beverly "Poppy" Douglas, Jr., born on Sept. 7, 1926, died October 17, 2018. He was educated at Peabody Demonstration School, Vanderbilt, and Princeton University. In 1950, he received his law degree from Vanderbilt University, and in 1951, he joined the U.S. Navy and served as an Intelligence Officer during the Korean War. He then practiced law with his father at Douglas and Douglas and , in 1956, moved to Columbia, to practice law with MacFarland, Colley and Douglas before beginning his long career at the Middle Tennessee Bank where he was a loan officer, president, and eventually, chairman of the board. He retired in 1998. His sense of humor, curiosity, love of learning, and interest in other people kept him engaged through the end of his life. Poppy delighted his grandchildren

by reading aloud, gardening, building forts, telling stories, and indulging creative play of all sorts. He inspired a sense of wonder and adventure, cherished his independence, and was energized by his interest in the lives of others. He loved nothing more than to spend time in Monteagle with friends and family, encouraging visitors of all ages to join him on his porch.

He was an active leader at the Downtown Presbyterian Church in Nashville, The First Presbyterian Church in Columbia, the United Givers Fund, and the Columbia-Mt. Pleasant Chamber of Commerce.

He is survived by his daughter Frances Douglas Corzine (Brooks), grandchildren Zara, Douglas, and George Corzine, and four nieces and nephews.



ARC Project Submission Deadlines

Planning a renovation project? The Architectural Review Committee will accept projects for review and recommendation to the Board of Trust for approval four times per year. Questions about possible projects, the process, and necessary requirements should be referred to the General Manager. Projects submitted by the following dates will be reviewed and presented at the board meeting following the submission.

January 15 May 1 July 15 September 30 The ARC is available throughout the year to advise members on their project planning prior to submission of a request. Not sure if you need ARC approval? Check with the General Manager first.
