From the President Much-Needed Maintenance Underway

Scott and his teams are making great progress on several projects that were recently approved by the board. Maintenance activities are not very exciting, but they are very important to the health of the Assembly.

- ▶ In the spring of 2019, the cracks in the mall tennis courts are scheduled to be repaired and then the courts will be resurfaced.
- ► The last phase of the perimeter fencing has been approved and should be completed prior to the opening of next season. Our maintenance staff is currently working on clearing and tree

removals on this section of the fence.

► The walk-in cooler in the dining hall has been scheduled for replacement.

Additional project news:

- ► The fall paving and road maintenance work has been delayed until the 2nd quarter of 2019. The paving contractor was unable to accommodate us in his schedule for 2018.
- ▶ We are currently investigating a foundation problem at Harton Hall and are working to determine the cause and extent of the problem.

Winter Prep: Don't Get Caught in the Cold



As we prepare for the colder months, it's important to assess your cottage's vulnerabilities and take care preventative maintenance:

- 1. Please check your smoke detector batteries.
- 2. Have your chimney inspected by a professional chimney sweep.
- 3. Shut off your water while you are away. Every year several cottage owners experience water leaks while their cottage is not occupied. Some of the leaks have been quite expensive. The Assembly does not allow for leak adjustments due to our utility relationship with the Town of Monteagle.
- 4. It gets really cold! Many of our cottages are built so the air circulates under the floor. This is great to keep us cool during the summer, but it plays havoc with the water

pipes during the winter (see #3).



- 5. Please let the office know when you loan your cottage to friends and family. We like for our security officers to keep a watch out for people and cars which are not familiar to the campus.
- 6. Don't be a stranger! The Assembly is beautiful in every season; try to enjoy it yearround.

COR Spotlight

As you may or may not know, the Assembly is regulated by two very important documents. One is the bylaws, and the other is the rules and regulations.

The bylaws are the specific rules that outline precisely how the Assembly is governed. The rules and regulations focus on our day-to-day life, including behavior and expectations. Both are included in the membership directory, and every member should read them every year.

That said, we continue a series of articles that will spotlight a different subject from the code

of regulation. This month: G9, alcohol.

The possession or use of alcoholic beverages or controlled substances on public grounds, in public places, or at public functions on the Assembly grounds is prohibited and subjects the offender to disciplinary action by the Board of Trustees except as follows:

During the season, alcoholic beverages may be allowed and may be consumed only at a location approved by the Board of Trustees on not more than four occasions per season and only during special events approved in advance by the board of trustees.

During the off-season, alcohol beverages shall be allowed and may be consumed only in connection with a private, invitation-only, function in one of the following areas set aside and reserved exclusively for such purpose private use and not then open to the public, and approved in advance by the board of trustees:

- \Rightarrow dining hall
- ⇒ gymnasium and adjacent tennis court
- \Rightarrow art pavilion
- ⇒ any tents temporarily attached to the above
- ⇒ other locations at the board's discretion

He is also survived by grandchildren, his brothers Jon Harvey Monfore (Kelseyville, CA) and Dr. Robert Gene Monfore (Bali, Indonesia), and a number of cousins, nieces and nephews. Bob was born in Springfield, South Dakota and enjoyed a diverse and impressive career, including attaining

In 1987, he established Monfore Group, Inc. ARC Project Submission Deadlines

Planning a renovation project? The Architectural Review Committee will accept projects for review and recommendation to the Board of Trust for approval four times per year. Questions about possible projects, the process, and necessary requirements should be referred to the General Manager. Projects submitted by the following dates will be reviewed and presented at the board meeting following the submission.

January 15 May 1 July 15 September 30 The ARC is available throughout the year to advise members on their project planning prior to submission of a request. Not sure if you need ARC approval? Check with the General Manager first.
