From the President Board News and COVID-19

The February 29 board meeting was a marathon meeting that lasted 3.5 hours.

Some of the Highlights: Financial Report: Cash balances are good with water and sewer expenses trending higher due to a water leak. (The leak was found and repaired on Thursday, March 6.)

General Managers report: The roofing projects on Warren Chapel and the Bell Tower are complete. The offers for the youth staff are in the final stages, and it appears we will have a large number of returning staffers.

ARC Committee: The board approved motions for modification and improvements for the following Cottages:

Cottage #9 ("Lexington" - Ferris and Neale) - Decorative addition to Roof

Cottage #61A ("Alabama House"-Rollins) – Replace windows on dining room addition

Cottage #61B ("Toadstool – Rollins) - Replace former balcony Cottage #56 ("Southern Comfort"-

Fox) – Revised drawing and for the secondary storage building.

The board approved the following motions concerning the ARC Process:

"The ARC committee be allowed to approve thru e-mail occasional minor changes only to those projects already approved by the MSSA Board of Trustees and already substantially in progress and only if approval is unanimous with all members of ARC reporting.

In the interest of expediting the installation of handrails when needed for safety considerations, the board approved the following motion: "Simple handrail designs endorsed by the ARC committee at the 1/31/2020 meeting may be installed with the approval of the General Manager."

COVID 19

There has been a lot of news about the virus, but a couple of things are certain: there are a lot of unknowns about the duration of COVID-19 and its socio-economic impact to the world, country and community. Scott Parrish and I have been communicating daily since early March, discussing some of the various scenarios and impacts this pandemic is causing, and we will continue to talk and evaluate the reports. We have modeled financial impacts, reviewed human resource requirements, CDC guidelines, state closure

requirements, playgrounds, public facilities cleaning, travel restrictions, etc. The list goes on and continues to change daily.

Ruth Cobb, platform superintendent, and Scott Parrish are 95-98 percent complete with final plans and preparations for the season and continue to be optimistic about the upcoming season. Unfortunately, we must also be realists and proactively plan for the "what if." If the virus continues to spread, will CDC or State and local governments put additional restrictions in place, more travel restrictions, tighter lockdowns, etc.? How will these effect MSSA? Could there being no season, or a delayed start to the season, a partial season say weeks four to eight, or a limited season where there is no dining hall, no group activities larger

than 10, fewer speakers? Lots of options but what are the risks?

As the number of cases and deaths rise is the U.S., it is becoming clear that the forecast crest of the bell curve will happen later rather than sooner. The next board of trustees meeting is scheduled for May 2 and should be the date when the Board of trustees will make the decision concerning what will happen for the season. The season opens on June 7, so the May 2 date will give us just a little over 30 days to adjust any of the platform plans, not to mention travel plans for the youth staff, speakers and other summer employees. The decision will have an impact on owners, renters, employees, the summer staff and the Town of Monteagle.

The final decision about the season must be made with the thought of safe-guarding the health and welfare of our members, families and community.

Planning a renovation project? The Architectural Review Committee will accept projects for review and recommendation to the Board of Trust for approval four times per year. Questions about possible projects, the process, and necessary requirements should be referred to the General Manager. Projects submitted by the following dates will be reviewed and presented at the board meeting following the submission.

June 10 July 31 September 30

January 15 February 28

The ARC is available throughout the year to advise members on their project planning prior to submission of a request. Not sure if you need ARC approval? Check with the General Manager first.
