Board News and COVID 19

Happy spring! It's a spring unlike we have ever experienced, but the the grounds look great, and there is still a lot of activity at MSSA.

As promised, here are additional highlights from the Feb 29th meeting:

- 1. Property Committee: Acting on a motion from the property committee, the executive committee moved that the MSSA board of trustees approve the purchase of the property at 922 Sunset Rock Road, funded through the Waldrop Land Acquisition fund. This property was identified as a priority parcel in the Strategic plan adopted by the MSSA BOT on Feb18, 2017.
- 2. Long Range Planning Committee: After meticulous research and careful consideration, the MSSA long range planning committee presented a number of motions and recommendations for consideration. I encourage you to review the minutes from the meeting for full details of each.

Leasehold Transfer Fee & Notice of Intent filing- Motion failed

Leasehold Transfer Fee if the cottage is a gift or bequest to a nonfamily member: This was referred back to the committee for value determination. Leasehold Mortgages: Motion failed

MSSA Board of Trustees size-"Reduction in board size by 1/3 (from 24 members to 16). Motion failed.

Creation of board liaisons: Recommendation declined

Board meeting Schedule: Minimum of 4 meetings per year, to be held quarterly. Motion passed.

I encourage every member to read the minutes of this meeting as it contains the details of the motions and recommendations of the longrange planning committee. Be sure to thank the members of the longrange planning committee for their work--I am hopeful that as we evolve and grow, the LRP will continue to help us recognize potential roadblocks to our viability and challenge our thinking, all for the health and betterment of MSSA.



ARC PROJECT SUBMISSION DEADLINES

Planning a renovation project? The Architectural Review Committee will accept projects for review and recommendation to the Board of Trust for approval four times per year. Questions about possible projects, the process, and necessary requirements should be referred to the General Manager. Projects submitted by the following dates will be reviewed and presented at the board meeting following the submission.

June 10 July 31 September 30

January 15 February 28

The ARC is available throughout the year to advise members on their project planning prior to submission of a request. Not sure if you need ARC approval? Check with the General Manager first.
