From Our Board President

I hope you all had a glorious Thanksgiving holiday! I was in Monteagle, and it was so wonderful to connect with dear friends and family, rest my mind and spirit, and simply feel the peace that comes from spending time on our beautiful Assembly grounds.

Having had a post-turkey board meeting and some great conversations with committees chairs at the potluck, it's clear we have all had a productive fall. Plans for the 2025 program are taking shape under the leadership of Susan Acker. The Youth Committee is incredibly excited about developing a roster of engaging activities for our children and grandchildren, and the Warren Chapel committee is pouring its heart and soul into providing us all with a season of outstanding fellowship opportunities.

Thank you to everyone who participated in the pickleball survey. It was an important exercise that helped us quantify the depth of interest in the issue and guided us as we developed these critical next steps:

1. First and foremost, the Board reconfirmed its commitment to further investigate an appropriate location and funding for additional courts.



2. The Board approved a motion removing the previous three-year deadline for the completion of the new pickleball courts and the subsequent return of the current courts to youth activities. Some members may be disappointed by this, but please consider that the motion was made in June 2022, meaning that the courts would have to be complete by June 2025. That is simply not feasible. And we hope the membership will agree that with a project of this magnitude, it is far more important to "get it right" than to do it fast. We are committed to finding the best site with the fewest negative impacts while also focusing on funding and long-term maintenance.

3. The Board passed a motion to omit the VFW and current court location from consideration. Consideration of new sites in line with the Master Plan remains a possibility.

- 4. I have appointed an ad hoc committee comprised of the chairs of property, long range planning, Pickleball and trails (each chair will choose one additional person from their respective committee as well). This Ad Hoc Committee is charged with spearheading the effort to determine the best site, design and construction of new courts while keeping in mind our Master Plan and any potential effects on our neighbors—both in and outside the Assembly—as well as any environmental concerns.
- 5. This Ad Hoc Committee (comprised of all volunteers) will provide reports at every upcoming board meeting. Updates will also be provided at Town Hall meetings during the

season, and through Mountain Voices at appropriate intervals.

The MSSA Board of Trustees views the concerns of the members as a top priority, and we hope that you will please contact any board member with questions you may have regarding pickleball, a part of the process outlined above, or any other issue that is of importance to you. My children often hear this refrain from me: "I can't solve a problem that I don't know exists." I am confident that together, with open minds, open hearts, mutual respect and a long history of community, we can tackle any problem.
