Updates from the Office and the Grounds

The Assembly remains very active much of the fall with weddings, workshops, and the Sewanee weekends. I've also enjoyed seeing and visiting with our many members, their families and guests who have had the good fortune to be here. Please do not hesitate to call the office with any concerns or needs.

Staff, Grounds Crew and Security:

We are fully staffed in the office and the grounds crew remains busy with property improvements . . . in addition to their usual heavy fall schedule. Also, as noted in last month's issue, please welcome Marty Sampley to the security team. Additional offseason shifts have been added to the customary nightly security rounds.



Trees:

The grounds crew has been busy identifying and removing dangerous or dead trees on Assembly property, both inside the gates and on the trails. Please let the office know if you have concerns about any



trees. We welcome your feedback Of note, several trees (plus one cottage, Shady Dell and two vehicles) were impacted during recent fall storms. Fortunately, we suffered no major damage, and there have been no injuries.

Trails: East trail renovations and additions have begun including new bridges and a new trail segment that runs between the ash tree stumps and the campground. More to come soon including campground upgrades.

Sewer Rehab Update:

The Town of Monteagle's 3rd party engineering firm has completed the majority of the work required on property. They have a few clean up items and road repairs to finalize over the next months, but so far, they are ahead of schedule and should be off the grounds well in advance of next summer.

Water Shutoff/Trash:

It's close to time to act for those who plan to shut off their water supply for the winter. Brief reminder that the Monteagle Utility District does not provide the Assembly Leaseholds forgiveness for high water bills due to leaks or broken lines. Lastly, don't forget to let the office know if you want your trash pickup stopped.
